Findings in the audit of the Hermann Contract License Office

Background

The Department of Revenue (DOR) has appointed 177 contract agents to operate contract license offices across the state. These offices process transactions to issue driver licenses; titles for motor vehicles, trailers, and marine craft; and license plates. Contract agents are compensated through transaction-based processing fees. Under a state law, which became effective in 2009, the state auditor may audit contract license offices.

Prepayment Void Transactions

Prepayment void transactions occur when transactions are voided before payment is made, such as when the customer lacks sufficient funds or the entry has incorrect information. DOR procedures require an independent supervisory review of voided transactions, a documented reason for voiding a transaction, and customer acknowledgment if a new transaction is not completed or is for a lesser amount. License office management personnel did not perform independent supervisory reviews for 6 of 10 prepayment void transactions that occurred from September 27 through October 18, 2016. In addition, license office personnel did not obtain customer acknowledgment for all 3 applicable transactions or document the reasons for voiding 1 of these transactions.

Statutory Compliance

Poor:

License office personnel do not normally inquire if customers want to donate to the organ donor program, blindness awareness program, and the World War I Memorial Trust Fund, as required by state law.

In the areas audited, the overall performance of this entity was **Good**.*
